

## Food Supply – Common Agricultural Policy (CAP) and Common Fisheries Policy (CFP) of the EU

**Objectives** (see Article 39 of the Treaty on the Functioning of the European Union TFEU):

- 1.to increase productivity, by promoting technical progress and ensuring the optimum use of the factors of production, in particular labour;
- 2.to ensure a fair standard of living for the agricultural Community;
- 3.to stabilise markets:
- 4.to secure availability of supplies;
- 5.to provide consumers with food at reasonable prices.

Four **Components** of the CFP:

- 1. Regulation of production, quality, grading, packaging and labelling
- 2. Encouraging producer organisations intended to protect fishermen from sudden market changes
- 3. Setting minimum fish prices and financing buying up of unsold fish
- 4. Set rules for trade with non-EU countries



## Securing Availability of Supplies – Supply Balance Agriculture



### Supply Balance Agricultural **Products in Germany:**

The degree of self-sufficiency is a scale to measure the fullfillment of the CAP-goal of a sufficient supply of the population


It shows the extent to which domestic agriculture can cover demand (total consumption). proportion The exported other countries to is deducted from domestic production, and the imported proportion is added.

Art. 39 TFEU obliges the Member States to ensure reliability of supply:

- Sufficient production of basic foodstuffs (inward)
- Trade policy to ensure sufficient supply with external agricultural products (outward)
- Supply of the needs of final consumers AND of processing industry (ECJ C-131/87)




## **Food Safety**

- European Basic Foodstuff Regulation No 178/2002/EC (EU-Basic-Regulation) – Foundation of a European Authority for Food Safety (EFSA) and Definition of Procedures for Food Safety
- Regulation No 852/2004/EC on Food Hygiene (Basic Hygiene Rules and Duty for Food Producers to *hazard analysis and critical control points HACCP* Procedures)
- Specific Rules for animal food products in Regulations No 853 and 854/2004/EC
- EU => Only food products which fulfill the rules of HACCP are admitted to enter and trade within the EU-market
- See Private Hygienecenter in Munster (Information for the Industry Management), Hygiene Certification i.e. DQS or TÜV Cert (not obligatory in EU-Law)



## **Antagonism and Balance**




Important factor is a responsible consumer (Consumer as 'Change Agent')

Corona Hotspots in Meatfabrics due to specific working conditions of East-European workers






Changing of production processes in Brasil due to import conditions of the EU to avoid danger of intoxication of consumers with mold on Paranuts
